Can We Afford To Keep Raising The Cost Of Doing Business?

When government mandates businesses to pay more in wages regardless of the actual fair-market values of minimum-wage labor, it artificially forces businesses to increase operating overhead. Anyone who has ever run an enterprise knows increasing overhead costs adversely affect products and services they provide their customers. When costs go up, one of four things must happen: 1) cost of your goods or services to your customer goes up; or 2) the quality of your goods or services goes down; or 3) cut workers' hours or impose a hiring freeze; or 4) cut profits or operate at a loss.

The big government pushers believe businesses are greedy and can always afford wage increases. 'Look at the rich owner's Mercedes; he needs to spread the wealth around,' they would say. The reality is when you increase the wages of minimum-wage workers (or entry-level jobs that should be determined by the free market) that means, for example, the low cost food services whose customers are those who can't afford fancy restaurants, will have to buy food at higher prices or lower quality. So those who can't afford caviar will now be penalized by the government mandate.

If the owner keeps the price the same and lowers quality to try and survive, they'll lose customers because of bad burgers. Eventually he will lose his business anyway from a lack of patronage. Alternatively, he can freeze hiring or cut workers' hours, but that, of course, hurts his employees. Then there's the option of operating at zero profit or at a loss. Now, try to keep up with inflation – another government-induced

I have grave concerns regarding the nine anti-Second Amendment bills recently proposed in the General Assembly, including the 17+% tax on firearms and ammunition

Attempts to tax or charge a fee for the exercise of a civil right, such as last year's ill-fated proposal by Representative Finn, have been repeatedly struck down by the courts. Such laws are blatantly discriminatory, disenfranchising the poor.

There's a more sinister side as well. In the eyes of the courts all civil rights guaranteed by the Constitution must be considered equal. A restriction allowed on one establishes the precedent to apply similar restrictions to the others. Are you willing to pay Representative Finn's \$100.00 fee, be fingerprinted and background checked each time you vote? If you accept the nonsensical arguments for ten-round magazine limits for firearms, you may also have to accept a ten-word limit on your freedom of speech. Do you believe the Second Amendment doesn't apply to semiautomatic firearms because the Founders couldn't have envisioned them? If you do, then the First Amendment doesn't apply to movies, television, or any electronic media, giving government the right to monitor, censor, and tax you each time you use a phone or access the internet. Can't happen? The NSA is already monitoring your phone calls and e-mails on behalf of an administration infamous for its abuse of power. Limits on your rights may be closer than you think.

This begs the question why any elected representative would be so irresponsible as to author, introduce, or support legislation attacking the Bill of Rights, specifically the Second Amendment.
